The annual fee is \$100.00 for the school year. No discount rates are offered to siblings or additional children. **PAYMENT IS DUE AT TIME OF REGISTRATION. IF THE FEE IS NOT PAID, YOUR CHILD WILL NOT BE PICKED UP. PAYMENTS ARE MADE BY CASH, CHECK, MONEY ORDER OR CREDIT CARD. NO REFUNDS.**

ABSENTEES:

If your child does not attend school on a given day, the After School Transportation fee will not be reduced. If your child's fees are paid and for any reason your child does not receive service, there are **NO REFUNDS. If your child does not attend school, you must notify the Club in the morning before 12:00 pm or there will be a \$10.00 charge for not notifying the Club.** If your child is not waiting in the designated pick-up area at the time the Van/Bus arrives, your child will be left behind.. **IT IS NOT THE BOYS & GIRLS CLUB'S RESPONSIBILITY TO SEARCH THE SCHOOL GROUNDS FOR YOUR CHILD. IT IS THE RESPONSIBILITY OF THE PARENT TO SEE THAT YOUR CHILD IS WAITING AT THE DESIGNATED AREA EVERY DAY ON TIME. Minimum of four (4) youth must be enrolled per school in order for the Club to provide the service.**

Van/Bus Passenger Rules:

1. No food shall be eaten while riding in the Van/Bus.
2. Remain in your seats at all times. Seat belts must be fasten securely in Van.
3. Refrain from loud disturbing conversation.
4. No throwing objects inside or outside the vehicle.
5. No cursing or put downs.
6. No putting your head or arms outside the Vehicle.

THE FOLLOWING SECTION ON THE RULES AND LAWS RELATION TO THE PUBLIC TRANSPORTATION IN CALIFORNIA IS QUOTED TO POINT OUT TO YOU THE AUTHORITY AND RESPONSIBILITY OF THE DRIVER OF THE BUS.

Section 1089, Authority Driver, Pupils transported in a school bus shall be under the authority of and responsible directly to the driver of the bus. The driver shall be held responsible for orderly conduct of the pupils while they are on the bus being escorted across a street, highway or road. Continued disorderly conduct or persistent refusal to submit the authority of the driver will result in the denial of transportation privileges.

Any behavior that requires the driver to either stop the bus/van or discipline a child more that once is cause for suspension of the after school transportation program.
